Herewith we transfer the approval as "BMW Longlife-04" oil, given for engine oil code to the Reblend oil "WOLF OFFICIALTECH 5W-30 C2/C3 EXTRA", SAE 5W-30 (oil code 65666) of Wolf Oil Corporation N.V.. Consequently it is approved according to our release procedure for BMW Longlife engine oils (12th edition, May 2026) for the usage in BMW engines operating in compliance with our operating fluids manual.

This confirmation is valid for two years beginning with the date of this letter and can be further extended for a maximum of two years in each case (approval expires prematurely if the reference formulation loses its approval). Prolongations have to be requested within BFAS (BMW Fluid Approval System), the extension date can be taken from BFAS, reference EOA-RBL-2026-06285.

Engine oils produced using the code or brand names mentioned in this letter of confirmation have to comply with the tested oil sample in every respect. Any proposed alteration or modification to the lubricant has to be supplied to BMW in BFAS whereby a new approval may be granted.
