Herewith we transfer the approval as "BMW Longlife-04" oil, given for engine oil code "65644" of "Wolf Oil Corporation N.V." to the Rebrand oil "CHAMPION OEM SPECIFIC 5W-30 C3 LL III", SAE 5W-30 (oil code 65644) of Champion Chemicals N.V.. Consequently it is approved according to our release procedure for BMW Longlife engine oils (1<sup>st</sup> edition, April 2024) for the usage in BMW engines operating in compliance with our operating fluids manual.

This confirmation is valid for two years beginning with the date of this letter and can be further extended for a maximum of two years in each case (approval expires prematurely if the reference formulation loses its approval). Prolongations have to be requested within BFAS (BMW Fluid Approval System), the extension date can be taken from BFAS, reference EOA-RBR-2025-05684.


